

## VISA REQUIRMENTS FOR RESIDENTS IN SINGAPORE

1. APPLICANTS WHO ARE RESIDING IN SINGAPORE ARE ELIGIBLE FOR MULTIPLE ENTRY VISA TO MALAYSIA.
2. VISA APPLICATION FORM SHOULD BE DULY FILLED AND SIGNED BY THE APPLICANT HIMSELF OR THE SPONSOR.
3. PASSPORT VALIDITY SHOULD BE MORE THAN NINE MONTH.
4. ONE RECENT WHITE BACKGROUND PHOTOGRAPH TAKEN LESS THAN 6 MONTHS IS REQUIRED (3.5×5.5 CM), MUST SHOW THE EARS AND FOREHEAD & NO SLEEVELESS PHOTO.
5. COPY OF RESIDENTIAL STATUS IN SINGAPORE, MINIMUM PASS VALIDITY MORE THAN 3 MONTHS REQUIRED. (EMPLOYMENT PASS/LONG TERM SOCIAL VISIT PASS/STUDENT PASSES ETC).
6. PERMANENT RESIDENTS IN SINGAPORE MUST ATTACH A COPY OF **RE ENTRY PERMIT** ENDORSEMENT OR **FORM 7** ALONG WITH YOUR APPLICATION FORMS (MORE THAN 3 MONTHS VALIDITY).
7. VISA FEE (SEE VISA REQUIREMENTS/FEE FOR COUNTRIES).
8. MUSTAFA SERVICE CHARGES S\$9.90 CENTS (EXCLUDE EMABASSY FEE & MEVAS FEE).
9. VISA PROCESSING DURATION 3 TO 4 EMBASSY WORKING DAYS.
10. VISA WILL BE ISSUED ONLY ACCORDING TO THE PASSPORT VALIDITY AND SINGAPORE RESIDENTIAL PASS VALIDITY (MAXIMUM ONE YEAR).
11. THE VALIDITY OF MULTIPLE ENTRY VISA IS FROM ONE MONTH TO ONE YEAR.
